UNFINISHED BUSINESS

1. Update of Fenton Sand and Gravel land deposit.

Treasurer Bunting-Smith said Fenton Sand and Gravel's installment payments to purchase the rights of the 34 acre property are overdue. She said she has contacted the owner Vaughn Smith; he is aware payments are overdue, says he will make a payment, but doesn't.

Trustee Walker moved to direct the township attorney to contact Mr. Smith and Mr. Langdon regarding the late payments. (Trustee Schultz seconded.) The motion carried; all ayes.

NEW BUSINESS

1. Request of Robert Wooten to appeal a fire run charge.

Mrs. Wooten was burning near the roadside. A caller said the smoke was interfering with visibility. The fire department arrived and discovered the owners had no burn permit. Treasurer Bunting-Smith moved to deny the Wooten's request to waive the fire charge. (Trustee Gonzalez seconded.) The motion carried; all ayes.

2. Appointment of Don LoVasco from alternate to full member of the Zoning Board of Appeals.

Treasurer Bunting-Smith moved to approve the Supervisor's appointment of Don LoVasco to the Zoning Board of Appeals. (Trustee Gonzalez seconded.) The motion carried; all ayes. The appointment fills the vacancy created by Ryan Rudzis' resignation. The term expires August 31, 2014.

3. Request to schedule a joint meeting with Planning Commission.

Clerk Kremer moved to schedule a joint meeting with the Planning Commission on June 17, 2014. (Treasurer Bunting-Smith seconded.) The motion carried; all ayes.

4. Hartland Road repair estimates from Road Commission.

Two estimates were provided to the board from the Livingston County Road Commission:

The first estimate was \$250,000 to repair the southern half of Hartland Road, between the city of Fenton border and White Lake Rd. Clerk Kremer moved to accept the estimate of \$250,000, not to exceed 10%, to repair the section of Hartland Road. (Trustee Schultz seconded.) The motion carried; all ayes.

The second estimate of \$37,000 is for tree removal and gravel installation on Hartland Road, north of Gordon Road. \$30,000 was for the gravel and \$7,000 was estimated for the tree trimming/removal. Clerk Kremer said he felt \$7,000 was too much for tree removal on just a section of road and more trees could be removed in several areas if they were to bid the job out. Clerk Kremer moved to have the road commission identify dead trees in other areas of the township, then request bids for tree removal to be paid with road-right-of-way funds. (Trustee Walker seconded.) The motion carried; all ayes.

Trustee Gonzalez moved to accept the estimate of \$30,000 to install gravel on a section of Hartland Road, north of Gordon Rd. (Trustee Pedersen seconded.) The motion carried; 5 ayes, 2 nays (Kremer, Bunting-Smith)

5. Request to adopt Bridges and Highways Ordinance amendments.
