RESOLUTION #160101 TYRONE TOWNSHIP, LIVINGSTON COUNTY

SEWER BONDS DEBT REDUCTION GUIDELINES

WHEREAS, Tyrone Township entered into an agreement to fund a sewer project with bonds to be paid by township and guaranteed with Livingston County's bonding capacity,

WHEREAS, the bonds were sold on the premise that they would be paid by committed payments from property owners that were connecting to the sewer and additional forecasted growth,

WHEREAS, the anticipated growth never occurred and a large number of properties did not make their committed payments due to the economic downturn, which caused the bond fund to be unable to meet future payments and would potentially cause a default of the bond that Livingston County would be then be required to assist with paying the shortfall,

WHEREAS, in 2009, the Livingston County Commissioners through their debt committee, requested that the township prepare a long term debt reduction plan that would meet with the approval of the county,

WHEREAS, the plan prepared by the township included long term loans from the township general fund through the budget year 2028/2029 and a debt reduction fee on all quarterly billings to sewer users. The loans would continue and the debt reduction fee would continue until the bonds were totally paid off and the loans from the general fund were repaid. The plan was made purposely conservative such that it did not have to revised with additional loans should the economic downturn continue for a long period of time,

WHEREAS, actual user connections have been increasing, tax delinquencies with the larger properties are abating, and a significant amount of tax losses have been recovered by the township purchasing these properties and reselling them,

WHEREAS, in 2015 a revised plan was submitted to the Livingston County Commissioners with the following assumptions and conditions:

- Forecasted growth in usage was limited to the new connections required by current homeowners within the sewer district in 2018. No additional new users or new REUs will be counted until actually connected and paid or committed via a new special assessment.
- The O&M debt reduction fee would continue until the bond and General Fund loans are repaid.
- The forecasted cash balance at the beginning of each year would exceed the required bond payments for that year.
- Payback of the loan would not occur until the cash balance at the beginning of the fiscal year would be sufficient to repay all the outstanding bond payments.
- General Fund loans to the sewer fund would be discontinued after 2016/2017 providing the forecasted cash balance at the end of a fiscal year exceeded the bond payments for the coming fiscal year. In the event, the forecasted cash balance was not sufficient to pay any of future years' bond payments, General Fund loans would need to be reinstated to bring the plan back into compliance.

- The plan will be updated each year with the ending cash balance in the fund, the actual
- If requested, the township board would prepare updated reports for the Livingston County Debt Committee.

NOW THEREFORE BE IT RESOLVED that Tyrone Township Board will review the long term sewer bond repayment plan on an annual basis to assure that the provisions outlined above will be followed or adjusted to meet the future bond repayment requirements.
