Hartland Consolidated Schools Bonding Proposal	
<p>Shall Hartland Consolidated Schools, Livingston County, Michigan, borrow the sum of not to exceed Forty-Five Million Dollars (\$45,000,000) and issue its general obligation unlimited tax bonds therefor, in one or more series, for the purpose of:</p> <ul style="list-style-type: none"> - remodeling, equipping and re-equipping and furnishing and refurbishing school buildings, including STEM/collaboration centers and safety and security improvements; - acquiring, installing, and equipping or re-equipping school buildings for instructional technology; - purchasing school buses; - erecting, furnishing and equipping additions to school buildings; - erecting, furnishing and equipping athletic support structures at the middle school and high school; and - preparing, developing, improving and equipping athletic fields and facilities and sites? <p>The following is for informational purposes only:</p> <p>The estimated millage that will be levied for the proposed bonds in 2020, under current law, is 1.44 mills (\$1.44 on each \$1,000 of taxable valuation). The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is twenty-five (25) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 1.25 mills (\$1.25 on each \$1,000 of taxable valuation).</p> <p>The school district does not expect to borrow from the State to pay debt service on the bonds. The total amount of qualified bonds currently outstanding is \$122,095,000. The total amount of qualified loans currently outstanding is approximately \$48,696.
