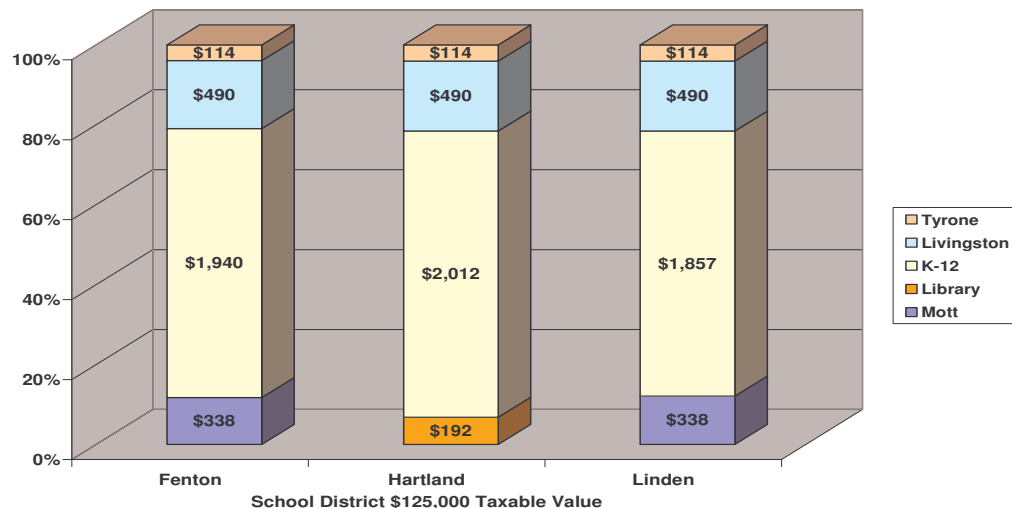
Township Financial Status

Revenue Source

Tyrone Township receives its income from Property Taxes, State Revenue Sharing, Franchise Fees, and other fees which include passport processing, administrative fees, dog licensing, permits, and other minor sources.

If you own a house with a taxable value of \$125,000 the township receives \$114.00. If your property has a lower taxable value, you pay less. Review the chart to see where the rest your property tax dollars go. Total revenue for the current fiscal year is expected to be \$60,000 less than last year.

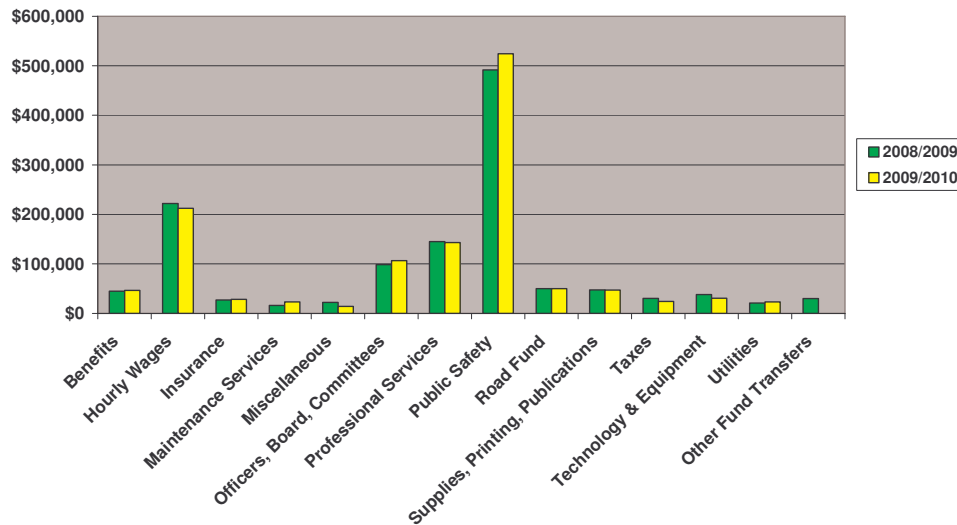
Where Your Tax Dollars Go



Expenses

Public Safety is rapidly eating up the budget. Today it is nearing 50% and will eclipse it in a few years. The large deficit in income from the sewer fund also threatens the budget. Beyond what the township is legally required to do, there is little room in the budget to eliminate more expenses. Any reduction in staff would almost certainly lose more in fees than the reduction in personnel would save. The chart below provides a picture of where the township spends its funds. Our budget calls for spending less in this year than last.

Outlook

According to most forecasts we can expect to see a decrease in taxable value of about 20% over the next three years which amount to about \$80,000 less in property taxes alone.

In addition, if the state cannot solve its budget problems, we could see an additional reduction in our state revenue sharing. We have already taken a \$28,000 decrease for this year and more may be coming.

Burning Update

Watch for a revised burning ordinance in the coming weeks. It will be published on the township web site www.tyronetownship.us. You may complete a burn permit application at Tyrone Township or print and complete one from the Township website. The completed burn permit application MUST be received by the Township to be in effect. The burn permit application may be faxed, but you MUST have confirmation the fax was received by the Township.

Planning a project or business

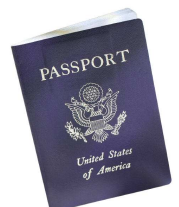

Citizen Communications

Do you want to know what is happening in the township without having to look for it?

Dog Licensing

All dogs must be licensed in Livingston County. You can purchase a license at the Township Hall or Livingston County. Proof of rabies vaccination and spraying/neutering (if applicable) must be shown every year as required by state statute. Make checks payable to Tyrone Township if paying at the Township Hall. **The Cost for a new spayed or neutered dog is \$7.00. Puppies are \$7.00. A new dog that is not spayed/neutered is \$25.00. Dog licenses that are renewed late (after 3/2/09) are \$30.00.**

Notary Service

Tyrone Township has a notary public on staff. This service is **free** for residents of Tyrone Township. There is a charge of \$2.50 per document for non-residents.

Residents of Linden and Fenton Schools District can get library cards at the Genesee County District Library System.

Residents living in Hartland School District can get their library card at the Cromaine Library.

Don't forget to get a Michicard for your card from your library. This allows library privileges to any participating library in the state.

Summer Tax Deferrals

A taxpayer who is a senior citizen, paraplegic, quadriplegic, eligible service person or veteran, eligible widow/widower, or who is totally and permanently disabled or blind may be able to delay paying the summer taxes on his or her homestead until February 28, 2010. Deferral forms may be obtained at the Township or on the Township website.

If eligible: Taxpayers may file their intent to defer until September 15, 2009.

Taxes

The summer tax bill will be sent out July 1st, due September 14, 2009. If paid after September 14, 2009, a 1% interest is added on each month. If you do not receive your tax bill or you have a new mailing address, please call 810-629-8631. **Failure to receive your tax bill does not waive interest.**

Public Safety Services

All public safety services are provided through contracts. Livingston County provides police protection and the Fenton Township, City of Fenton and in some instances Hartland/Deerfield Fire Authority (H DFA) provides fire protection and EMS support.

In addition to the normal service provided by the Livingston County Sheriff's Department through your county taxes, Tyrone and Hartland Township share a contract for a deputy sheriff to improve our coverage, quality of service and response times. To request police services all you need to do is call 911!

Any 911 call for fire protection is provided by the City of Fenton, Fenton Township or H DFA fire departments. In addition, when you call for emergency services for medical or auto accidents, the 911 operator may dispatch the fire department to provide support for the ambulance team. Each time the fire department is dispatched (with the exception of runs to LSA), Tyrone Township is billed by the fire department.

Tyrone Township's Emergency Recovery Ordinance requires us to bill the recipient for fire calls and EMS support services. Fire calls are billed to the recipient at the current rate in effect which is \$1300-\$1400 per event. The only exception is that Lake Shannon homeowners pay Hartland H DFD a flat contracted fee of \$120 per year.

Tree Trimming

Kappen Tree Service, LLC will be trimming trees around Consumer's Energy's power lines that run through sections 22, 27, 28, and 33 in Tyrone Township. This is scheduled to be completed by August 1st, 2009. The Power lines start between Center Road and Mabley Hill (Northeast corner of section 22), and go Southwest to Parshall Road into Hartland Township. Special Citizens Committees

Tyrone Township's Board of Trustees has formed two special citizens committees.

The first is the **Sewer Bond Repayment Committee**. Due to poor economy and lack of new construction in Michigan for the last 8 years, the sewer bond repayment fund will have a shortfall in the next 18 months. The committee was formed to explore alternative ways to meet the obligations of repaying the bond. The board feels that finding a solution on our own is more palatable than some solution forced on us by an outside source. The members of the committee are chairman Dave Kurtz , Ruth Beecherl, John Leibold, Mark Meisel, and Susan Spellicy.

The second committee is the **Public Safety Funding Committee**. The committee is charged with reviewing the current methods we use to fund public safety and their long term impact on the township's ability to provide these services. The committee members are chairman Brian Miles, Betty Carlson, Marv Frankel, Craig Hering, Jim Kolhoff, Keith Kremer, Mark McCaffery, Steve Nagy, and Ronald Stokes.
