TOWNSHIP BOARD OF TRUSTEES ELECTIONS

All seven seats for the Tyrone Township Board of Trustees are up for election, which occurs every four years, following the same schedule as the presidential election. The seats are for the supervisor, treasurer, clerk and four trustees. Candidates for the major parties (Republican and Democratic) must have submitted a nominating petition for election by May 15, 2012 to be listed on the August Primary Ballot. Winners of the Primary Election are then candidates for their respective parties in November. The Primary is August 7, 2012 and the General Election is November 6, 2012.

Minor parties select their own slate of candidates for the November Ballot.

Candidates with no party affiliation must submit their nominating petitions and Affidavit of Identity to appear on the November Ballot by 4:00 pm, July 19, 2012.

CIDER MILL CROSSING UPDATE

Sun Communities, the new owner of Cider Mill Crossing, has made significant progress in bringing the location up to standards. Taxes have been paid, the club house has been renovated, 25 new homes and 2 previously owned homes have been added and plans are underway for additional new units. During the summer, we expect more work to be done at the site.

New Laws Simplify Military & Overseas Voting

If you or someone you know is in the military or works overseas, you can now receive your ballot via e-mail or fax to speed up obtaining your ballot. If a military or civilian overseas voter is interested in obtaining ballots for future elections, they must request a ballot through the local clerk's office. For security purposes, a voted ballot still must be returned via mail.

Treasurer's Note

The 2012 Summer Tax Bills are mailed out to all Tyrone Township property owners July 1, 2012. The Summer Taxes are due September 14th. As of September 15, a 1% per month interest charge is assessed on unpaid summer taxes. The 2012 Winter Tax Bills will be mailed out to all Tyrone Township property owners on December 1, 2012 and are payable through February 28, 2013. ***Postmarks will not be accepted as the date paid.*** Any payments to be made after February 28th, 2013 need to be paid at Livingston County Treasures Office.

With online banking becoming more prevalent, we wanted to bring a few things to your attention. Most banks use a third party to process checks requested through their online bill payment system. This means that your money is deducted from your account and sent to the third party processor, not directly to the designated payee. **Bills paid through your online banking system may take up to 15 business days to be received.**

Attention Tax Payers!

Please Note!! Summer 2012 tax season is the last season for collecting your payment with post marked envelopes. Starting Winter 2012 tax season we will only accept payments received on, or before February 28th, 2013. Post marks will not be accepted!

DOG LICENSE RENEWAL REMINDER

Dog licenses must be renewed in the same month that your dog's rabies shot was given. If your dog was vaccinated in July you must obtain your dog license before the end of July or pay late fees. If you just had your dog vaccinated, you may purchase a three year license if your dog's rabies shot is valid for three years. If your dog's rabies shot expires in less than three years, you may only purchase a one year license. Proof of an unexpired rabies vaccination valid for at least one more year is required at the time you renew your license.

RETIRE YOUR AMERICAN FLAG PROPERLY

According to law, worn out American Flags must be disposed of properly. Boy Scout Troup 219 will provide American Flag retirement as a community service. If you have an old flag you want to retire, you may drop it off at the township hall and we will have the Boy Scouts properly retire your flag.

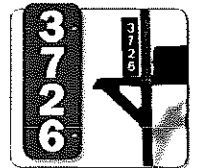
