### **2013/2014 Budgeting**

Over the next several months beginning in December 2012, the Board of Trustees will be reviewing and approving budgets for the fiscal year beginning April 1, 2013 through March 31, 2014. We encourage you to attend the township meetings in order to better understand the township finances and other activities.

### **Dog License Renewals**

Dog licenses must be renewed in the same month as the rabies shot was given. 1 year and 3 year licenses are available depending on the expiration of rabies. If your dog's rabies shot is good for three years, you may purchase a license that is valid for three years. Proof of rabies is required for license renewal.

### **BURN PERMITS**

Burn permits are required for any open fire. Burning of leaves and yard clipping are only allowed from April 1st to May 31st and September 15th to November 15th. When you have an open fire, you are responsible for making sure that you comply with the Open Burning ordinance (fire size, wind conditions, fire location, water supply etc.) You may get a copy of the Open Burning ordinance at [www.tyronetownship.us](http://www.tyronetownship.us).

From time to time an extended ban on open burning may be in effect. Please check with your fire department for more information. If you burn without a permit or do not follow the burning guidelines and the fire department is dispatched to the burn site, you automatically will be charged the fees that the township pays for the fire run. Burn permits, which are five dollars (\$5.00) and good for the entire calendar year, can be obtained at the township hall.
