40.202 Sec. 2. SPEED OF VESSELS.

Regulation No. 47, Livingston County.

R 281.747.9. Canal connected to Marl Lake; slow - no wake speed.

On the canal connected to Marl Lake; in the west $\frac{1}{4}$ of the northwest $\frac{1}{4}$ of section 4, town 4 north, range 6 east, Tyrone Township, Livingston County, it is unlawful for the operator of a vessel to exceed a slow - no wake speed.

TYRONE TOWNSHIP SPECIAL BOARD MEETING
April 2, 1973

A special board meeting was held April 2, 1973 at the Tyrone Township Hall. Meeting called by Supervisor Lee Gordon. Meeting called to order by Chairman Gordon at 7:40 PM. Members present Lyons, Hill, Hyde, Gordon and Becker. Clerk presented amendments to Tyrone Township Zoning Ordinance NO. 2 as advertised in the Fenton Independent January 11, 1973 and February 1, 1973 Sec. 4:12 shall be amended by adding the following: Before construction is started on such road, a Land Use Permit shall be secured from the Tyrone Zoning Administrator. The following conditions must be met by the applicant before a Land Use Permit shall be granted. (1) Plans and specifications for the road shall be approved by the Livingston County Road Commission. (2) The applicant shall agree to pay all inspection fees. (3) The applicant shall post a bond for the amount of \$1,000.00. Sec. 8:05 shall be amended by adding the following: All measurements referred to in this article shall be measured from the road right of way. Motion by Lyons seconded by Hyde to approve amendments to Tyrone Township Ordinance NO. 2 as presented and ask the Livingston County Road Commission to review plans and specifications for Private Roads as stated in subsection 4:12. Motion carried. Motion by Hill to advertise the road oil program and ask for payment with order stating the Township will pay for half up to 100 feet each order. Seconded by Becker. Carried. Motion by Hill seconded by Lyons that Lee Gordon be appointed full time Ordinance Enforcing Officer. Carried. Motion by Becker to recess meeting to meet with the Planning Commission. Motion by Hyde that the board approve Forest Hills No. 4 as approved by the Planning Commission. Seconded by Lyons. Hill no, Hyde Yes, Becker Yes, Lyons yes. Forest Hills No. 4 signed by the Clerk Carroll Becker. Motion to adjourn by Hyde seconded by Hill. Meeting adjourned.
